HEALTH GUARANTEE

- TCK guarantees that the dog is in good health and has received appropriate care including inoculations, worming & microchip. TCK will provide Buyer with a medical chart detailing treatment the dog has received under TCK's care, and future care TCK feels is essential to the dog's well being. Our health guarantee does not include external or internal parasites once the dog leaves TCK. All puppies will see our veterinarian at the time of weaning, and a Certificate of Veterinary Inspection will be provided as proof of this visit. No puppy will be allowed to leave TCK before it has been seen by our Veterinarian, or before they are 10 weeks of age. Any puppy being shipped must have a Health Certificate issued, if done with the puppy visit; this cost is an additional \$15. If we must schedule a second appointment for this certificate, you will be given a copy of the bill from that date and you are responsible for the full cost before the puppy is shipped.
- TCK guarantees that the dog is free of life threatening diseases or disabilities (i.e., heart murmurs, etc.) for 72 hours after delivery to Buyer. With the exception of "Innocent Heart Murmurs" which are typically outgrown. Should life threatening diseases or disabilities be discovered by Buyer within 72 hours after receipt of the dog, and attested to in writing to TCK by Buyer's veterinarian. TCK will provide Buyer with a replacement dog as soon as such a dog is available. TCK strongly recommends that Buyer have the dog examined by a licensed veterinarian of Buyer's choice within 72 hours of receipt of dog. Our veterinarian will happily send any records pertaining to your puppy directly to your veterinarian; just have your veterinarian call our veterinarian at 715-257-7003.
- No other guarantee is given except in the case of a hereditary or congenital defect which develops to the extent it renders the dog unsuitable as a pet. In this instance we offer a 2 year genetic health guarantee with veterinary proof. **This guarantee will be extended to 3 years in the event that said dog is given NuVet Plus daily. You can order this product, by calling 800-474-7044, using ID Code: 62722, or by visiting <http://www.nuvet.com/62722>. NuVet automatically sends me detailed customer information, so there will be proof of continued usage of NuVet with your puppy.** In this instance a replacement dog will be given to the purchaser in exchange for said dog's registration papers and certification that said dog has been spayed, neutered or destroyed. If said dog is to be destroyed, guarantee is valid only if the TCK gives prior approval. TCK will replace dog with an equal or better quality as one becomes available. Please note, parents of replacement dog may differ from those of original dog. Color and gender may be different as well if approved by both parties. **At no time will any cash refunds be given nor is TCK responsible for any veterinary bills.**
- We do NOT guarantee eye color; we only guarantee that they will be free of congenital eye diseases.

GENERAL

- The dog is registered with the American Kennel Club (AKC) and buyer will be furnished with all necessary paperwork and/or registration papers. Said dog may NOT be registered with any other registries without written approval from TCK.
- Any dog sold on a Spay/Neuter Contract will receive AKC Limited Registration only, new owner is required to have a licensed veterinarian spay/neuter puppy after 6 months of age but by 2 years of age. At TCK, we do not recommend spaying or neutering before 6 months of age.
- Any dog sold on a Breeding/Show contract may not bred before 1 year of age if a male, or 2 years of age if a female. This means the female may not be bred before her second birth date. Any breeding occurring before she is 2 years of age constitutes a breach in contract with penalties as listed below. In the case of a male, should he sire a litter before his first birth date, it constitutes a breach in contract. We recommend that they have their eyes & hip clearances done prior to breeding. Any puppies produced by said dog may not be sold to a Pet Store or a breeder who sells to a Pet Store. TCK reserves the right to request an evaluation puppy from any mating occurring with a dog produced or sold by TCK for breeding/show purposes. TCK also reserves the right to restrict breeding rights on pups resulting from said breeding(s), in such case as either evaluation pups or restrictive breeding rights are being stipulated, they will be notated below.

- Buyer agrees that all recommended vaccinations will be kept current and said dog will receive monthly heartworm preventatives. Dog shall be fed quality food and have fresh water available at all times. The dog will always have safe, comfortable and adequate shelter. At any time, should TCK learn that said dog is not being cared for properly and is attested to by a veterinarian in writing, or TCK learns an individual has faced charges for animal cruelty, neglect, abuse, etc., TCK will take custody of said dog and consider this action as a breach in contract by the buyer with all penalties as stated below. As Siberians love to run, please keep your new dog on a leash or in a fenced area. We cannot and will not be held responsible or liable for a dog that becomes lost. The primary residence of the purchaser is where the dog will be housed. All dogs must be licensed by your county or state of residence.
 - This dog is being sold with the intention of providing companionship to the Buyer for the rest of the dog's natural life which on average is 12 to 15 years. Should the Buyer want to re-home said dog for any reason at a later date, buyer will notify TCK in writing. Unless approved by TCK in writing to re-home said dog, said dog must be returned to TCK with all appropriate paperwork for placement by TCK in a suitable home. If this dog is sold or re-homed without prior approval in writing by TCK, it is a breach in contract, at which time, all guarantees become null and void and AKC will be notified to freeze said dog's registration. If TCK agrees to a placement, TCK must be notified as to where the dog goes. This is for record keeping as well as assuring that all pups are in happy healthy homes. **The dog shall never be turned over to the Humane Society, Rescue or Pound.**
 - TCK strongly recommends that Buyer attend puppy & obedience classes with the dog and provide proper socialization opportunities for the dog. TCK shall not be held responsible for acts of the dog which are due to Buyers negligence and or lack of training/socialization of said dog.

"I hereby state that I have read, fully understand, and agree to all the terms and conditions set forth in this contract. I understand this contract is enforceable under current American Kennel Club rules regarding Contracts and Registration Matters. I understand that failure to comply with this contract as written will result in permanent loss of the right to have the dog registered in my/our name(s). If either party is forced to take legal action to enforce any part of this contract; action shall be in the county of the TCK's residence. Any legal fees and court cost shall be the responsibility of the party found to be at fault. TCK reserves the right to fine the Buyer \$1,500.00 and TCK will repossess the dog if a breach of contract occurs. If said dog is out of state, buyer will be responsible for any fees associated with getting said dog back to TCK."
